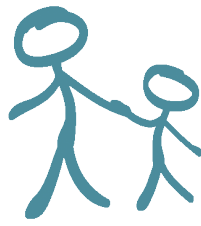

First, our three eighth grade graduates are moving on to strong high school programs. Keyshayia Beane and Anita Collins were both accepted to competitive selective enrollment public high schools in Chicago, which are among the best in the state. Keyshayia will be going to Gwendolyn Brooks, and Anita will be at Westinghouse. Also, virtual student Kaiyse Forney is going to a special digital media program at Hyde Park Academy.

Next, we had a successful Spring Awards Celebration on April 28, where we honored Lindy and Patrick Salvi of Salvi Schostok & Pritchard with the Abraham Lincoln Marovitz Philanthropic Award for their commitment to good works and public service. The My Hero Award was given to Derrick Thompson, Jr., of Taft Stettinius & Hollister, for his longtime mentoring of college athletes of color at Northwestern University.
